Talking calculators are shipped in a white, hard-shell container, closed with a zip-tie, via United Parcel Service (UPS).

Included in the container are: 1) the talking calculator; 2) power pack; 3) ear buds; 4) an instruction manual; 5) a UPS pre-paid pre-addressed shipping label (for sending back to NYSED); and 6) a zip-tie for closing the container., when returning the contents to NYSED HSE Office. Be sure to keep the shipper's copy (your copy) of the UPS mailing label for your records when you return the container.

The HSE Office has a very limited number of talking calculators. Please return within 2 days, after use in testing. Email the HSE Office when you have returned it via UPS. The email address is <u>HSE@NYSED.GOV</u> - include in the email subject line: "Talking Calculator Being Returned"
