DEFINITIONS FOR THE FIRST DESTINATION RECORD

Individual Student Educational Outcome Form

First Destination Reporting

Information regarding a student's pursuits immediately after graduation from a Licensed Private Career School.

OEDS Reporting Year & Reporting Period

By April 1st of each year, all schools are required to report the statistical data of the previous period of July 1st to June 30th. For example, by April 1st of 2026 (the **OEDS Reporting Year**), a school will report statistics for the period of July 1, 2024, to June 30, 2025 (the **OEDS Reporting Period**).

In Occupation

For graduates of proprietary schools, "in occupation" generally means being employed in a field or job that their training program prepared them for, typically a vocational or technical field.

Related Field

In the context of proprietary school graduates, "related fields" generally refers to occupations or career paths that are similar to or utilize the skills and knowledge gained through the specific vocational or technical training provided by the school.

Unrelated Field

"Unrelated field" generally refers to occupations or career paths that are not similar to or do not utilize the skills and knowledge gained through the specific vocational or technical training provided by the school.

Further Education

For graduates of proprietary schools, "further education" generally means the student has enrolled at another school or learning institution.

Seeking Employment

This category is defined as those graduates who have indicated that they are seeking employment or engaged in the job-search process.

Status Unknown/ "No information Available"

This category is defined as those graduates who, despite reasonable efforts on the part of the institution, have not responded to requests to obtain information about their postgraduation career plans.

Unavailable for Employment

This category is defined as those graduates who are deemed unavailable for unemployment due to death, incarceration, active military, a medical condition that prevents employment, continuing education or international students who returned to their country of origin.
