A subsidy letter is a support provided by an employer to assist the US Social Security Administration (SSA) in determining if the work performed is Substantial Gainful Activity that may result in an employee receiving more pay than their actual

value of services they perform.

ALBANY - CDCI Saratoga County Employment and Training One-Stop in Ballston

Spa changed its practices to permit CDCI staff to meet with consumers regularly for two half days on a bi-weekly basis at the

facility.

AMSTERDAM - RCIL Northeast Career Planning (NCP) made a procedural change to

facilitate a more efficient process for referring consumers to the Center's Work Incentive Planning and Assistance (WIPA) project funded through the US Social Security Administration from only referring consumers receiving supported employment follow-along services when their Ticket to Work is assignable to referring consumers when the referral for employment services is first received. NCP is a non-profit vocational rehabilitation organization with its main office in Albany and six offices in the

Capital Region.

AMSTERDAM - RCIL Rehabilitation Initiatives (RI) in Albany changed its procedures to

include in each consumer's Individual Work Plan a

recommendation for services through the Center's Work Incentive Planning and Assistance (WIPA) project funded through the US Social Security Administration (SSA). RI is an approved SSA Employment Network providing Ticket to Work services to Supplemental Security Income (SSI)/Social Security Disability Insurance (SSDI) beneficiaries in Rensselaer, Saratoga and

Schenectady Counties.

AUBURN - OFI Jacobs Press, a printing company in Auburn, changed its staff

training procedures to have Options for Independence regularly conduct Disability Awareness and Sensitivity training for its

personnel.

BATAVIA - ILGR

Genesee County Career Center, One-Stop in Batavia, changed its practices to have staff training routinely include a presentation on ILGR's Independent Living Philosophy and services.

BRONX - BILS

Applebee's Neighborhood Grill and Bar at 4750-4758 Third Avenue in Bronx changed its recruitment policies to allow persons with visual impairments to be assisted with the employment application process in the actual restaurant. Previously, all applicants were required to apply online at the Applebee's website that was inaccessible.

Center applied for and was awarded a 5 year Federal grant through the American Recovery and Reinvestment Act of 2009 (ARRA) to conduct Project ARRA NOW an employment preparation program to work with youth with disabilities and their families in Chemung and Steuben Counties.

CORNING - AIM

NYS Office For People With Developmental Disabilities (OPWDD) established a fee-for-service contract with the Center to provide extended supported employment services in Chemung and Steuben Counties.

CORNING - AIM

Thomas Edison High School in Elmira Heights established an agreement with AIM to provide Project ARRA NOW to mainstreamed special education students and their families. The project provides classroom and on-the-job training to improve employability and address barriers to finding employment.

GLENS FALLS - SAIL

KINGSTON - RCAL

Client Assistance Program (CAP) through the Westchester Independent Living Center (WILC) changed its practices to schedule regular and periodic meetings at RCAL. Previously, consumers had to travel from Ulster County to Westchester County for CAP services. CAP is a federal program administered by the NYS Commission on Quality of Care and Advocacy for Persons with Disabilities (CQCAPD) to assist individuals with disabilities with problems encountered while seeking vocational rehabilitation, employment, and independent living services.

KINGSTON - RCAL

Ulster County Vocational Steering Committee established a letter of agreement for its members to utilize a decision tree when providing benefits counseling to ensure consistent dissemination of information, consumer referral to a higher level of service if needed, and attendance at staff trainings. The decision tree was developed with the assistance of Cornell University in Ithaca.

The Task Force's mission is to increase public safety and to reduce recidivism by developing a strong reentry system that emphasizes evidence-based principles and approaches to address the needs of formerly incarcerated individuals that cause or promote crime.

ALBANY - CDCI

Center staff serves on the Police-Mental Health Crisis Intervention Network that works to promote the development and improvement of specialized policing responses to people with mental illness.

ALBANY - CDCI

Center staff serves on the Schenectady County Mental Health Forensic Task Force that works to improve treatment options and reduce the involvement of persons with mental illness in the criminal justice system. The Task Force is composed of criminal justice officials, mental health specialists, and advocates.

ALBANY - CDCI

Center staff serves on the Community Homeless Assessment and Local Education and Networking Group (CHALENG) that is part of the US Department of Veterans Affairs (VA) Health Care for Homeless Veterans Program and is conducted locally through the Stratton VA Medical Center in Albany. CHALENG is a partnership of communities nationwide to assess local needs and gaps in service to homeless veterans.

ALBANY - CDCI

Center was active in the statewide ILC effort that led to the passage and signing into law during August 2010 of NYS legislation that requires the State to develop model planning and zoning guidelines for communities to create compact, mixed-use senior housing and residential accessory dwelling units, called "granny flats." The new law also directs the State Office of Aging to recommend mixed-use-age-integrated housing or redevelopment demonstration projects in urban, suburban and rural areas of the state.

Making the OPWDD ombudsman, whose duties include advocating for people receiving services at state facilities, an employee of CQCAPD, which has a similar role with all the mental hygiene agencies, allows the ombudsman and CQCAPD to better pool resources and coordinate efforts in advocating for persons with developmental disabilities.

ROCHESTER - RCIL

Center was active in the national ILC effort that led to the passage and signing into law during October 2010 of Federal legislation known as the 21st Century Communications and Video Accessibility Act that requires smart phones, television programs and other modern communications technologies to be accessible to individuals with a vision or hearing disability.

ROCHESTER - RCIL

Monroe County Family Court improved its access to individuals who are Deaf or hard of hearing with limited English proficiency by providing both sign language interpreter services and foreign language interpreter services at the same time, when necessary.

ROCHESTER - RCIL

RCIL was invited to become a member of the Rochester Housing Authority (RHA) Family Self Sufficiency (FSS) Program Coordinating Committee (PCC). The PCC assists the PHA in securing public and private resources for the operation of the FSS program and in developing an Action Plan and implementing the program.

ROCKLAND - RILC

Town of Clarkstown improved the access of the pedestrian crosswalk at the intersection of Twin Elms Lane and South Main Street by installing material that provides visual and textural distinction, by improving the slope of the pavement for safer ambulation, and by adding improved striping.

ROCKLAND - RILC

Palisades Center mall in West Nyack reversed its decision to stop providing electric carts to customers who are disabled or elderly and will continue to supply carts as well as purchase new electric carts to increase the number offered for use. The mall's owner, Pyramid Companies in Syracuse that originally made the decision to stop providing carts, agreed to provide electric carts for disabled and elderly patrons in their other locations.

Town of Clarkstown in collaboration with RILC developed two different Communication Visor Cards and a Violation Card to assist in communication during a traffic stop between a police officer and a driver who is deaf or hard of hearing. The Visor Cards identify the driver as either deaf or hard of hearing and give instructions to minimize distractions and facilitate conversation. The Violation Card depicts various infractions; enabling the officer to point to which one he pulled the driver over for, i.e. stop sign.

ROCKLAND - RILC

Town of Clarkstown improved the access of the pedestrian crosswalk at the intersection of New City-Congers Road and South Main Street by installing material that provides visual and textural distinction, by improving the slope of the pavement for safer ambulation, and by adding improved striping.

STATEN ISLAND - SICIL

New Dorp Public Library established a written arrangement with SICIL to provide onsite computer and sensitivity trainings as a regular part of employee training.

STATEN ISLAND - SICIL New York City Police Department 120th Precinct in Staten Island changed its in-service training plan to include disability sensitivity training conducted by the Center to first responders.

STATEN ISLAND - SICIL

Staten Island Public Library system (12 branches) installed an updated version of JAWS screen reading software on all public computers to assist persons with visual impairment.

SUFFOLK - SILO

Town of Islip installed two accessible pedestrian crosswalks at the Central Islip High School on Wheeler Road.

SUFFOLK - SILO

Suffolk County Transit changed its in-service training plan to include Disability Sensitivity training conducted by the Center to fixed route/paratransit personnel.

SUFFOLK - SILO

Burger Shack at 3672 Route 112 in Coran now makes its menu available in Braille for customers who are blind.

SULLIVAN - ATI

Super 8 Motel in Monticello installed handicapped accessible parking aisle signage in its parking lot.

SULLIVAN - ATI

Sullivan County ARC in Monticello corrected the new handicapped accessible parking configuration and installed the access aisle signage in its parking lot.

SYRACUSE - ARISE

Syracuse Police Department incorporated disability awareness training provided by ARISE as a regular part of its training curriculum for all staff. The training will also cover Deaf culture and domestic/sexual violence and who these disciplines intersect.

SYRACUSE - ARISE

Central New York Regional Transportation Authority (CENTRO) changed its Call-A-Bus paratransit service application to add a statement that more accurately identifies a person's mobility limitations.

SYRACUSE - ARISE

Onondaga County Department of Social Services (DSS) revised and implemented a comprehensive Americans with Disabilities Act (ADA) Policy that provides increased protections and requires DSS to provide various reasonable accommodations for clients with disabilities. On the 2nd and 5th floors of the DSS building in Syracuse, signs and flyers about ADA rights and responsibilities were posted in numerous locations. Also on the 2nd floor DSS waiting room, brochure racks were repositioned and placed in an easy-to-reach location for wheelchair users.

Bennett Manor Apartments in East Syracuse restriped the entire parking lot of 100 spaces and numbered each space according to apartment numbers, created twenty designated handicapped accessible parking spaces in front of the building with four access aisles and vertical signage posted for each space, added a new accessible CENTRO bus stop with two accessible parking spaces and an extra wide access aisle for wheelchair pickup and drop-off; and installed at the front entrance power-assisted doors with push button access and an accessible pick-up and drop-off area for private bus transportation.

Bon-Ton department store in Camillus restriped the main parking lot to install four handicapped accessible parking spaces and access aisles with vertical signs for all of the parking spaces and access aisles.

SYRACUSE - ARISE

Rite Aid Pharmacy at 300 West Manlius Street in East Syracuse restriped the parking lot to install three handicapped accessible parking spaces and access aisles with vertical signs for each parking space and access aisle, removed a ramp from an access aisle and installed a curb cut in front of the accessible entrance cut, installed a power-assisted door with push button access at the main entrance, and moved merchandise and shelves to keep the entrance clear.

TROY - ILCHV

Zone Five Law Enforcement Academy in Schenectady incorporated ILCHV's curriculum "Persons with Disabilities" as a regular component of its classes to train local law enforcement officers. The Academy provides training to over 65 state, county, city, town and village police agencies in a geographical area covering the ten counties of the Zone and other agencies that have joined from adjacent zones.

TROY - ILCHV

Lens Crafters (retail prescription eyewear) changed practices at its Capital District area stores at Colonie Center, Crossgates Mall, and Rotterdam Square Mall to provide sign language interpreter services to customers who are deaf or hard of hearing.

TROY - ILCHV

Center was active in the statewide ILC effort that led to passage and signing into law during August 2011 of State legislation that requires state and local transportation agencies to consider "complete streets" designs that will make streets and roadways across the state safe and accessible to all users.

The new law repeals an outdated waiver process that allowed for the continued usage of sites that are not ADA compliant.
