Under the court ruling, the New Rochelle School District was required to establish an evacuation plan, to permit students with disabilities to regularly participate in evacuation drills, to provide training on Title II of the Americans with Disabilities Act (ADA) to school personnel, and to provide reasonable accommodations, such as evacuation chairs.

YONKERS - WDOM

Center staff served on the newly established local Business Advisory Council that will work with WDOM's Project Search, a school-to-work transition program serving high school seniors that provides integrated educational-vocational experience in the workplace.

MHATI is a case management program that provides individual service coordination to people with mental illness who have been arrested and sentenced by the court to participate in treatment services.

Village of Nyack Housing Authority amended its lease agreement to add a clause exempting service animals to the no-pet policy, to add a reasonable accommodation policy, and to remove the question "Are you disabled?". Nyack Housing Authority owns and operates three public housing facilities (Waldron Terrace, Depew Manor and the Nyack Senior Center).

Rockland County Department of Public Transportation T.R.I.P.S. paratransit service amended its by-laws to allow consumer representation for each agency represented on the Board of Directors.

STATEN ISLAND - SICIL

St. George Staten Island Ferry Terminal in Staten Island installed Automatic Identification System (AIS) monitors to inform individuals who are deaf/hard of hearing of changes in the ferry boat schedules.

The AIS system allows passengers to see where the ferries are in the harbor while waiting for them at the terminal.

STATEN ISLAND - SICIL DaNoi Restaurant at 138 Fingerboard Road in Staten Island provided its menu in Braille for customers who are blind.

The amendments align the County's law more closely with New York State Human Rights Law.

Town of Southold installed an audible pedestrian signal light at the intersection of Route 25 and Youngs Avenue.

CountryMax, farm and garden products retailer at 7031 Manlius Center Road in East Syracuse, installed vertical signs for the existing accessible parking spaces at the front entrance.

City of Oswego changed the ramp application procedures from requiring standard paperwork be completed in hard copy for each application to permitting this paperwork be completed once and maintained in an electronic master file for use when a new application is submitted. Having this foundation paperwork accepted for all ramp applications shortens the application process by about 3 weeks.

Heman Street Senior Apartment, new complex located in the former Heman Street School in East Syracuse, provided the correct mailbox key so the postal service could deliver the mail and the residents would not have to go in person to the Main Post Office. The original mailbox key given to the postal service for the apartment complex did not fit the lock.

MASSENA - MILC

St. Lawrence County Government added to its website on the St. Lawrence County Partner Agencies page a link to the Massena Independent Living Center website as a local provider of services.

OLEAN - DIL

Advocates for Community Tolerance (ACT) in collaboration with DIL established a regularly scheduled voter registration event for students at Jamestown Community College to be held on campus for several days at the end of the semester. ACT is an Olean-area group that addresses bullying issues in the community.

OLEAN - DIL

As a result of DIL's active involvement in complaints to the NYS Office of the Attorney General against the Allegany County Board of Elections (ACBOE) for most polling sites mot meeting state and federal accessibility requirements, the ACBOE brought 33 of 34 polling sites into compliance with the Americans with Disabilities Act. The 1 remaining polling site not yet accessible is the Town of Independence Town Hall.

PLATTSBURGH - NCCI

NCCI's Long Term Ombudsman Coordinator served on the Board of Trustees of the Village of Champlain.

POUGHKEEPSIE - TRI

NYS Senator Terry Gipson representing Senate District 41, which serves portions of Dutchess County and Putnam County, with a district office in Poughkeepsie provided sign language interpreter services for meetings and rallies.

PUTNAM - PILS

PILS Director of Systems Advocacy served on the Putnam County Disaster Preparedness Committee for Special Populations that is affiliated with the County Bureau of Emergency Services. The Committee's purpose is to plan conferences and events regarding emergency preparedness information dissemination to county residents with an emphasis on special/vulnerable populations.

PUTNAM - PILS

PILS Director of Systems Advocacy served on the Putnam County Emergency Management Committee that is affiliated with the County Bureau of Emergency Services. The overall Purpose of the Committee is Disaster preparedness.

QUEENS - CIDNY

UTICA - RCIL

Oneida County Health Department changed its Public Health Emergency Response and Preparedness Program to include the needs of the deaf and other persons with disabilities in all disaster preparedness exercises.

UTICA - RCIL

RCIL is a member of Herkimer Oneida Organizations Active in Disaster (HOOAD) Long-Term Recovery Group that is a voluntary community collaborative formed as a result of the 2013 disastrous flooding in Herkimer and Oneida Counties. HOOAD is affiliated with the NYS Voluntary Organizations Active in Disaster (VOAD), a nonprofit membership organization that serves as the forum where organizations share knowledge and resources throughout the disaster cycle to help disaster survivors and their communities.

WHITE PLAINS - WILC

WILC Director of Systems Advocacy served on the Westchester Volunteer Coordination Subcommittee of the United Way of Westchester and Putnam in White Plains. The Subcommittee's mission is to establish a coalition to build a community's capacity for long term recovery when disaster occurs.

WHITE PLAINS - WILC

WILC Director of Systems Advocacy served on the Westchester Long Term Recovery Coalition, which is a volunteer coalition of non-profit agencies that works to address emergency management solutions for persons with disabilities.
