### **SRC Quarterly Meeting Public Comments**

Public comments may be sent to [ACCESSRC@nysed.gov](mailto:ACCESSRC@nysed.gov) or provided in person during the designated public comment time on the SRC quarterly agenda. Members of the public may attend virtually if a virtual link is provided on the agenda.

Process for public comment during an SRC Quarterly Meeting:

- At the beginning of each meeting day, attendance will be taken.
  - *In-person Meetings*: Public attendees will be advised comments are limited to the designated public comment period.
  - *Virtual Meetings*: Public attendees will be advised of the designated public comment period and that their microphones will be muted except for those commenting at the designated time.
- After attendance and instructions have been completed on the first day of the SRC quarterly meeting, the public comment period will be open.
  - The SRC Chair will ask if there are individuals who would like to make a public comment.
  - Comments will be provided in the order of the individuals recognized by the SRC Chair.
  - Public comments will be limited to two minutes per attendee. All public comments must meet appropriate norms of public discourse, and refrain from use of expletives or inflammatory rhetoric. Commenters will be held to this standard at the discretion of the SRC Chair.
